Registration Fees are \$25 per child, \$75 maximum per family. Make checks payable to the Mountain Lakes Recreation Commission. Registration Closes on March 8, 2010.

Mountain Lakes Junior Track is Recreation Commission sponsored program, and a member of the Lakeland Junior Track & Field League. By league rules, age groups are determined by the child's age as of 12/31/10. The track program is divided into two major groups. The youngest team is named the "Clinic" and is for children 8 years and younger. **To participate in the clinic program, children must still be 8 years old or younger as of 10/01/10.** The 9 and up team is divided into 6 competition groups as 9/10, 11/12 and 13/14. Boys and girls compete separately. **We will place your child in the proper group based upon their age and gender.** At the meets, each group competes against the same age and gender group for points based upon their place in an event. The points scored from all the groups are combined for a team score.

The Junior Track Association is a volunteer organization, dependent on parent participation. **By registering, parents are signifying their willingness to participate in the program.**

I, the undersigned, being the parent or legal guardian of the above named child(ren) do hereby grant permission for participation in all activities sponsored by the Lakeland Junior Track League and the Mountain Lakes Junior Track Association. I assume all risks and hazards incidental to such participation and release the Mountain Lakes Junior Track Association and the Lakeland Junior Track League and their agents and Assigns from any liability and/or responsibility for any injuries sustained by my child(ren) or expenses incurred there from while engaged in or traveling to or from any activities of the above-named organizations.

Further, I attest that my child(ren) named above is (are) in good health and able to participate in the Mountain Lakes Junior Track program. I agree to indicate on this form and to notify my child's coach if there are any medical conditions of which he or she should be aware.
